Employment Resources, Adapt's Supported Employment program, is once again operating the Summer Youth Program. The program started in June and runs through August. The Summer Youth Program provides students aged 15-18 years with work-based learning experiences. The program is a collaborative effort between Adapt, Michigan Rehabilitation Services (MRS), Coldwater Community -

Schools, the Branch Intermediate School District (BISD), and the Branch Area Career Center (BACC). Employment Resources assists with transportation and provides Job Coaching to the students.

Each student has spent two hours in soft skills training (interacting with peers and supervisors, how to dress for work, how to follow instructions, work ethic, attendance, etc.) to prepare for their real work experience. This year we are fortunate to work with Indiana Pokagon State Park. Outdoor work is performed daily unless it rains, and then indoor work is performed. Weeding, trimming, and janitorial are the main duties.

Students complete four weeks of work experience, working 20 hours a week, earning minimum wage. There are two of these four-week sessions and four students enrolled in each session. During the first session, there was one student who decided the program was not for her. Students who have finished the 1st session met and ate lunch at the Potawatomi Inn on July 7th. Tammy from Pokagon thanked each student with a small gift AND offered them direct employment next summer!

Employment Resources

Alan Pomranka was referred to us by Michigan Rehabilitation Services. Alan uses a wheelchair and was having great difficulty finding suitable employment. He has a shining personality, is pleasant and friendly, and is capable of doing many jobs.

Amy, our Job Developer/Job Coach began working with Alan. They contacted several employers before finding the perfect job match. Alan was growing very concerned that he was not being given the chance to prove he could be a valuable employee.

Amy worked tirelessly and was determined to find Alan the perfect job. She visited Holiday Inn and successfully secured Alan a job as nighttime desk auditor. He started the position with a four-week period of on-the-job evaluation (where Adapt remains the employer of record). After two weeks, Holiday Inn Express notified Alan and Amy that they wanted to hire Alan directly. Alan is now an Employee of Holiday Inn Express and doing an amazing job.

Alan and Amy formed a genuine relationship which is the cornerstone for making a successful job/worker match. We are so proud of them both, for Amy's determination and skills at developing jobs and for Alan's perseverance, work ethic, and strong interpersonal skills.

Thank you Amy and Alan for another example what hard work does when we are in service to others!

Annual Battle Jacks Ballgame

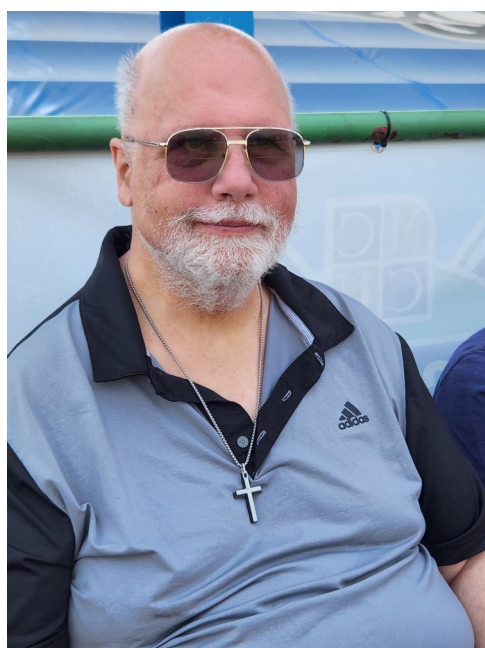

Outlook Clubhouse

Outlook Clubhouse had its second accreditation review with Clubhouse International from April 12th through the 14th. A Clubhouse International accreditation review is a systematic review of the entire Clubhouse program to ensure they are following all 37 standards developed by Clubhouse International. A two-person team, made up of a director and a member from another accredited Clubhouse, spent 3 days with Outlook Clubhouse. Both member and director interviewed Outlook's members, employees, director, advisory board, and administrative personnel about the program. The survey team participated in the work ordered day, visited work sites, met with Outlook's advisory board, and reviewed paperwork.
